Example 1

Through the statistics on the accident frequency in 2009, the rate of gas leaking which cause the accident in LiJia Sub-district has been sharply raising, 5 people have lost their lives. Among those, one of the major reasons is the lack of attention, such as the shortage on fire common sense, aging of the gas pipe, using some unusual pipe or equipments, some old people even forget to close the valve. Focus on these, we timely change our project in 2010, nearly 2 million yuan has been used to stall the gas alarm for the disabled old people and poor families freely. 1220 families have the chance to own the profit. Meanwhile, strengthen the wideness of propaganda. By using these, the possibilities causing accident of gas leaking has been reducing. Because of the gas alarm, erase the potential danger, and guarantee the life scurrility of the disadvantaged groups. Till now, no more people dead of gas poisoning.

Example 2

A positive social affects has been on since the foundation of the team named “helping others”, which adhering to the same theme. According to the reality of the area itself, focus on the matters on the disadvantaged groups, build the file of the disabled people, and change equipments of the electrical for them, drive disabled students to have examination freely. Etc. On the other hand, beyond sharing and uniting the sources with other departments, the team also goes to the home of the people who needed help instead of answering the phone only. Thus, the Sub-district has a whole helping system which can realize offering others anytime anywhere. What’s more, nearly 6 hundred million yuan has been cost to build a day care center in order to improve the environment of the old people, offer meals, cares and places to have entertainment, pay the bills for them and let them have the chance to have bath. Meanwhile, the center signed a contract with the community to insure that a check-up can be done regularly. And tell them the ways to keep bodies and mental healthy, lead them to read newspapers, books, talk to them and find ways to solve the mental troubles if they have.

Guideline 3—High-risk population/ Environment

6, In the past 12 months, please give details of your community for high-risk groups or environmental work and the results achieved.

There are 643 disabled people in LiJia Sub-district. Aiming at these people, a health and service team has been found which mainly contains mental disabled people. Lighter disabled people help the rehabilitation teachers to treat the mental disabled ones. Through this way, it

is no doubt more convenient to communicate with each other. On the other hand, it can still lighten the burdens of the families of the disabled people by offering their jobs. JinHua community and LvXiang community founded the Health Treatment Activity Room, do some kinds of treatment training by hiring professional doctors. All kinds of activities have been hold annually to fulfill the lives of the disabled people, which can improve the shapes of their bodies.

Construction site, which always is the main point in building the architecture, especially under the period of the development, the qualities of the workers are not the same, thus the management is lacking, which means that the scurrility in building the architectures is among the most important things we need to focus on. Though education, propaganda, and checking, 87 kinds of potential danger have been erased. Not a single death accident occurs in building the architecture of the entire year.

Revision the questionnaire of the past years, and make the context fit more like the area itself. 1000 pages of Questionnaire have been sent on the damage of the people and children in April, 2010. The rate of the recovery is 91% and 96%, which offers the accurate data for improving the project.

What we can find the Questionnaire:

- 1, The team of “helping others” has got people’s recognition and need to keep developing.
- 2, The phenomenon of the gas accident still exists, what we need is to control the accident by continue stalling the gas alarm for the disadvantaged groups.

Evaluation example one.

The main reasons of the traffic accident from 2007 to 2009.

- 1, Increase speed of the cars, the project of the subway, traffic jams;
- 2, Illegal driving, excessive speed of the cars, emergency cannot be disposed calmly;
- 3, Too much new drivers, Commuters drivers refused to give ground to each at the peak of the traffic;
- 4, Indifference to safety awareness , drunk driving, fatigue driving;

2007-2009 traffic accidents has been increasing, 2007, 2008, 2009 respectively occurred within 102 ,96, 110, the number of injured people were 35, 28, 21.

Continuous improvement plan

- 1, Signed letters of responsibility for traffic safety, require every driver to write a traffic safety guarantee, Increasing the propaganda of the traffic safety;
- 2, Accelerate the road construction, improving road condition;
- 3, Increase crossroads electronic command system;
- 4, Intensify punishment, hard punishing the phenomenon of drunk driving ,jump the red lights,grap the line and so on;
- 5, Strengthen the training for the new drivers in the simulated driving school.

Evaluation example 2

The reason of the gas accidents from 2007 to 2009

Indifferent to gas safety knowledge, pipeline aging and the lack of safety knowledge, 2007-2009 there were 11 gas safety accidents, respectively 3, 3, 5, and 7 people had died three years since.

Continuous improvement plan

- 1, Using various publicity means widely and deeply research on residents safety knowledge education, make all the people master gas safety knowledge, improve self prevention capacity;
- 2, Install a gas alarm for the household that enjoy family credit,widows ,orphans and other vulnerable groups;
- 3, Coordinate the gas company staff to strengthen resident pipeline overhaul;
- 4, Replace the aging gas pipeline;

Evaluation example three

The main reasons of the fire disaster from 2007 to 2009

- 1, The safety consciousness of the electricity and the gas of the residents is week, they pull wire disorderly, purpose socket lead to load overload, forget to close the gas valve etc;
- 2, Migrant workers always use large capacity appliances and stove fires and so on, that also easy to lead to a fire disaster;
- 3, The fire hidden danger of fire in the workplaces cannot be eliminated timely , they even do not check this timely,and the weak regime is also a reason;

2007-2009 there are 191 fire disasters, respectively, 59, 56, 76, the persons who were injured in the fire are 2, 1, 0, respectively , downtrend year by year.

Continuous improvement plan

- 1, Signed letters of responsibility with the enterprises;
- 2, Give full play to the voluntary community promoters and the floor seniors,strengthening the inspection and safety publicity of fire protection;
- 3, Carry out drills of the fire safety, using promoting center organizing residents and enterprise employees to participate in training, improve fire prevention safety awareness and self-rescue ability;
- 4, According to the season to carry out fire safety improvement, strengthen the propaganda education and implement the fire prevention safety regulations.

In the past 12 months, the challenges our community met is the firetrap that the face of the old district.

Countermeasures:

1. Many departments of the union eliminate the traffic facilities which block fire control passageway, give instructions of which damage fire control facilities, and order the relevant units to restore.
2. Strengthen safety culture in the hallway. Install safety publicity prompt in 2997 buildings of our areas.
3. Enhance residents' fire safety training and walkthrough, and improve fire safety awareness and their own ability.
4. To check regularly the security and eliminate potential timely.

In the past 12 months, the great opportunities my community met is to create the international safety community. On the basis of years of security communities, security community building and a new steps
